Mr Mun Hong Yew ("Mr Mun") is the sole shareholder of AVS Investments Pte. Ltd., which holds 100% of the issued and paid-up share capital of Azventure Investments Pte. Ltd. ("AZI"), a substantial shareholder of Aztech Global Ltd. Accordingly, for the purposes of Section 4 of the Securities and Futures Act 2001 of Singapore, Mr Mun is treated as having a deemed interest in the 542,197,600 Aztech Global Ltd. shares held by AZI ("Shares").

On 16 May 2023, Mr Mun acquired 500,000 Aztech Global Ltd. shares which are held by Raffles Nominees.

As part of an internal restructuring to rationalise Mr Mun's existing holding structure of the Shares, AZI has transferred all of its Shares to Mr Mun. Accordingly, AZI has ceased to hold any shares in Aztech Global Ltd. and Mr Mun holds the Shares directly in his name.
