Clova Investments Ltd is wholly owned by Mr Mun Hong Yew ("Mr Mun"), who is a Director/CEO and substantial shareholder of Aztech Global Ltd.

Clova Investments Ltd wholly owns Mun Siew Capital Pte. Ltd.

Prior to this transaction on 21 September 2023, Mr Mun held shares in Aztech Global Ltd. ("Shares") as follows: 6,250,000 Shares directly in his CDP account, 166,649,200 Shares through Raffles Nominees (Pte) Limited, 188,649,200 Shares through DBS Nominees Pte Ltd and 181,149,200 Shares through United Overseas Bank Nominees (Private) Limited. Each of the aforementioned nominee accounts are jointly held by Mr Mun and his spouse, Mdm Siew Yoke Ping ("Mdm Siew").

On 21 September 2023, Mr Mun and Mdm Siew transferred:

i) 33,000,000 Shares from the DBS Nominees Pte Ltd account jointly held by them to Mun Siew Capital Pte. Ltd.'s DBS Nominees Pte Ltd account; and

ii) 27,000,000 Shares from the United Overseas Bank Nominees (Private) Limited jointly held by them to Mun Siew Capital Pte. Ltd.'s United Overseas Bank Nominees (Private) Limited account.

As a result of this transaction on 21 September 2023, Clova Investments Ltd is deemed to be interested in the 33,000,000 Shares held through Mun Siew Capital Pte. Ltd.'s DBS Nominees Pte Ltd account and the 27,000,000 Shares held through Mun Siew Capital Pte. Ltd.'s United Overseas Bank Nominees (Private) Limited account.
