("Shares") as follows: 6,250,000 Shares directly in his CDP account, 166,649,200 Shares through Raffles Nominees (Pte) Limited, 188,649,200 Shares through DBS Nominees Pte Ltd and 181,149,200 Shares through United Overseas Bank Nominees (Private) Limited. Each of the aforementioned nominee accounts are held jointly by Mr Mun and his spouse, Mdm Siew Yoke Ping ("Mdm Siew").

On 21 September 2023, Mr Mun and Mdm Siew transferred:  
i) 33,000,000 Shares from the DBS Nominees Pte Ltd account jointly held by them to Mun Siew Capital Pte. Ltd.'s DBS Nominees Pte Ltd account; and  
ii) 27,000,000 Shares from the United Overseas Bank Nominees (Private) Limited jointly held by them to Mun Siew Capital Pte. Ltd.'s United Overseas Bank Nominees (Private) Limited account.

Mun Siew Capital Pte. Ltd. is wholly owned by Clova Investments Ltd, which is in turn wholly owned by Mr Mun.

As a result of this transaction on 21 September 2023,  
i) Mr Mun holds 6,250,000 Shares directly in his CDP account;  
ii) Mr Mun holds 166,649,200 Shares through Raffles Nominees (Pte) Limited, 155,649,200 Shares through DBS Nominees Pte Ltd and 154,149,200 Shares through United Overseas Bank Nominees (Private) Limited. Each of the aforementioned nominee accounts are held jointly by Mr Mun and Mdm Siew; and  
iii) Mr Mun is also deemed to be interested in the 33,000,000 Shares held in Mun Siew Capital Pte. Ltd.'s DBS Nominees Pte Ltd account and the 27,000,000 Shares held in Mun Siew Capital Pte. Ltd.'s United Overseas Bank Nominees (Private) Limited account.
