Prior to this transaction on 21 September 2023, Mdm Siew held 536,447,600 shares in Aztech Global Ltd ("Shares") in the following nominee accounts jointly held by Mr Mun and her: 166,649,200 Shares through Raffles Nominees (Pte) Limited, 188,649,200 Shares through DBS Nominees Pte Ltd and 181,149,200 Shares through United Overseas Bank Nominees (Private) Limited.

On 21 September 2023, Mr Mun and Mdm Siew transferred:
 i) 33,000,000 Shares from the DBS Nominees Pte Ltd account jointly held by them to Mun Siew Capital Pte. Ltd.'s DBS Nominees Pte Ltd account; and
 ii) 27,000,000 Shares from the United Overseas Bank Nominees (Private) Limited account jointly held by them to Mun Siew Capital Pte. Ltd.'s United Overseas Bank Nominees (Private) Limited account.

Mun Siew Capital Pte. Ltd. is wholly owned by Clova Investments Ltd, which is in turn wholly owned by Mr Mun.

As a result of this transaction on 21 September 2023, Mdm Siew is deemed to be interested in 476,447,600 Shares in the following nominee accounts jointly held by Mr Mun and her: 166,649,200 Shares through Raffles Nominees (Pte) Limited, 155,649,200 Shares through DBS Nominees Pte Ltd and 154,149,200 Shares through United Overseas Bank Nominees (Private) Limited.
